#### How much will NV Energy pay a month after a rate hike?

According to NV Energy, a person who uses the average amount of energy now would pay approximately \$11 per monthextra after the rate hike. There are still several meetings needed before it is passed. It could be negotiated down, but 9% is the maximum the hike can be with this request.

#### Is there a solar tax credit in Nevada?

Unfortunately, there is no state solar tax creditin Nevada. However, all Americans can claim 30% of the cost of their solar system as a deduction from their federal tax liability. After claiming the 30% tax credit, the final price of a typical 6 kW solar system is just \$11,172. Does NV Energy offer any solar rebates? Not anymore.

#### How much would a 9% energy rate hike cost?

An up to 9% rate hike is expected to be approved and go into effect later this year. According to NV Energy, a person who uses the average amount of energy now would pay approximately \$11 per monthextra after the rate hike. There are still several meetings needed before it is passed.
