What are the Act solar rebates?

ACT solar rebates are some of the nation's best! Read on to discover why. Aimed at homeowners who hold Australian Pensioner Concession or Veteran' Affairs Gold Card in the ACT, this solar rebate provides up to \$5,000 towards the installation of energy efficient products and sustainable home upgrades. Two separate payments rebates are available:

Can I get a rebate for rooftop solar?

If you have an eligible concession card, you may be able to apply for a rebate of up to \$2,500to install rooftop solar through the Home Energy Support Program. The rebate can be combined with a zero-interest loan of up to \$10,000 to reduce upfront costs. Zero-interest loans of up to \$15,000 are available through the Sustainable Household Scheme.

How do I get a Solar Rebate Act?

Two separate payments rebates are available: Before they can access this solar rebate ACT, homeowners need to attend a free online workshop which covers key program info and how to apply while helping you make choices about your energy efficient upgrades.

Can pensioners get a solar rebate?

With this ACT Government incentive, pensioners can access solar energy and efficient appliances at a lesser cost. Receive a \$2,500 rebateafter a solar installation and another \$2,500 rebate after installation of a reverse cycle air conditioning system or a hot water heat pump.

What are home energy support rebates?

Can I get a rebate if I install a solar system?

Receive a \$2,500 rebateafter a solar installation and another \$2,500 rebate after installation of a reverse cycle air conditioning system or a hot water heat pump. To be eligible for this program you need to meet the following criteria: Own and occupy the home in which the eligible product will be installed.

Under changes to the ACT government's Sustainable Household Scheme, only properties with an unimproved land value of \$450,000 or less can apply for an interest-free loan to install solar products.
