How does Alabama compensate for excess solar energy?

Instead of paying the full price for excess solar energy, Alabama allows its largest utility, Alabama Power, to pay pennies on the dollar for it.

Does Alabama Power pay less for third-party energy producers?

Alabama Power is paying lessfor power generated by third-party energy producers and imposing a cost for those companies to connect to its electricity grid. The rule was approved by the Alabama Public Service Commission (PSC) in March; took effect in April and applies to companies that can generate at least 100 kilowatts of electricity.

Is Alabama's solar fee about to go up?

In fact, that solar fee, one of the highest in the nation, is about to go up. The Alabama Public Service Commission on Tuesday granted Alabama Power's motion to dismiss a challenge to the fees it charges residential customers who use solar panels or other methods to generate their own electricity.

What is a solar tax abatement in Alabama?

In Alabama, a solar tax abatement is a property tax exemption for owners of qualifying renewable energy facilities. The abatement can exempt property tax on the additional value added to a home by a solar installation, for periods of 10 or 20 years, depending on the jurisdiction.

How does Alabama Power's Rate PAE save money?

Under rate PAE, your solar panels will reduce your bill in two ways. If you get electricity service from Alabama Power, you can sign up for their special Rate PAE, which stands for "Purchase of Alternate Energy."
