

Will Ameren Missouri build a solar power plant in 2024?

ST. LOUIS, March 21, 2024 /PRNewswire /-- Today Ameren Missouri, a subsidiary of Ameren Corporation (NYSE: AEE), received approval to build or acquire approximately 400 megawatts (MW) of solar energy. The first of the three solar projects is scheduled to go into service in 2025, with two more set to begin serving customers in 2026.

What is Ameren Missouri's renewable solutions program?

Ameren Missouri's Renewable Solutions Program is a subscription-based program that allows businesses to replace up to 100% of their total energy use with renewable resources like wind and solar. "Renewable Solutions offers price certainty with no market risk," said Greg Lovett, manager, energy services at Ameren Missouri.

How many solar farms will Missouri have by 2026?

Ameren Missouri plans to open four solar farms by 2026 capable of powering a combined 95,000 homes, the company announced Tuesday. Ameren, an investor-owned electric utility serving St. Louis and eastern Missouri, said in a release it would build or purchase the four solar farms, which would have a combined capacity of 550 megawatts.

Why is Ameren Missouri integrating low-cost energy sources?

"Thoughtfully integrating these new, low-cost energy sources with our existing generation fleet is one of the ways Ameren Missouri is providing our customers with the reliable, resilient and affordable energy they expect," said Mark Birk, chairman and president of Ameren Missouri.

What are Ameren's new solar farms?

The four solar farms are a leap forward in Ameren's plan to add a combined 2,800 megawatts of wind and solar power by the end of 2030. The additions are meant to help Ameren reach its target to reduce its carbon emissions by 60% by 2030, compared with 2005 levels. It hopes to reach 85% reduction by 2040 and net-zero emissions by 2045.

What projects are being developed by Ameren Missouri?

Vandalia Renewable Energy Center, a 50-MW project based in Vandalia, Missouri, to be self-developed by Ameren Missouri with a target in-service date of 2025. Split Rail Solar, a 300-MW project based in Warren County, Missouri, with a target in-service date of 2026 to be acquired by Ameren Missouri from Invenergy.
