Are electric vehicle charging stations regulated in California?

All cities and counties in California are required by law(AB 1236 (2015,Chiu) and AB 970 (2021,McCarty)) to streamline permitting processes for electric vehicle charging stations by limiting project review to health and safety requirements in an expedited timeframe.

#### Does Los Angeles have an EV charging station?

The city of Los Angeles is also making a difference by offering a streamlined process for obtaining apermit for an EV charging station. In May 2024, tax exemption measures adopted to support zero-emission transit buses will be assessed -- a step that could lead to updated tax rules.

#### How many EV chargers are there in California?

With more than 105,000public and shared private EV chargers, California is leading the way in terms of developing a charging infrastructure that is strong enough to support widespread EV adoption in the state.

#### How much does EV charging cost in California?

At-home EV charging is also significantly more cost-effective, with homeowners in California expecting to pay \$500-700 on average to fuel their EVs at home while public EV charging can cost anywhere from \$700-\$3,000+annually depending on the type of EV, mileage, and cost per kWh.

#### Do I need a planning permit for an EV charging station?

AB 1236 and AB 970 limit EVCS application review to building official consideration of health and safety standards and requirements; noplanning permit should be required for EV charging station applications. Our jurisdiction adopted an ordinance and checklist. What's next? Congratulations!
