

## **Are solar power contracts rates approved by the hawaii puc**

How often does the Hawaii Public Utilities Commission evaluate the RPS?

The Hawaii Public Utilities Commission is required by HRS § 269-95(4) to evaluate Hawaii's RPS every five years and report its findings to the Legislature. As part of this process, HNEI is required to submit their assessment of the achievability and effectiveness of the RPS to the Commission.

Will KIUC and Hawaii Island reach 40% by 2030?

As of 2022, KIUC and Hawaii Island have already achieved the 2030 goal. Based on current plans for the PUC approved Stage 1 and Stage 2 solar + storage projects, the HECO territory is expected to reach the 40% by 2030. However, force majeure and related supply chain issues have created problems for Stage 1 and Stage 2 projects.
