What are Arizona's solar laws?

Since renewable energy, and specifically solar, are complex and related to many aspects of our lives, there are many laws and related rules that apply. Arizona Revised Statures (ARS - the basic set of laws) ARS 44-1761 Solar Energy Devices - Definitions defines " solar device " in a very general sense.

How does Arizona law protect private property rights to solar energy?

Arizona law protects individual homeowners' private property rights to solar access by dissolving any local covenant, restriction or condition attached to a property deed that restricts the use of solar energy. This law sustained a legal challenge in 2000.

Can solar power power Arizona's future?

The proposals include incentives for customers who install solar energy technologies for their own homes and businesses. The Commission's Renewable Energy Standards encourage utilities to use solar, wind, biomass, biogas, geothermal and other similar technologies to generate " clean" energy to power Arizona's future.

Does Arizona have solar power?

Arizona's renewable generation has seen a shift in recent years. Solar energy accounted for 10% of the state's total electricity net generation from all sources in 2023. This is a significant change from the past, as conventional hydroelectric power once dominated Arizona's renewable generation.

Who can sell solar devices in Arizona?

Another set of laws and regulations define who can sell solar devices. The laws about tax credits and related items are issued by the Arizona Department of Revenue and the Arizona Commerce Authority. There is a requirement to register as a seller. Only registered sellerscan use the sales tax (Transaction Tax) exemption.

Can Arizona residents buy their own solar power plant?

There is an opportunity for Arizona residents to reduce their electricity bill by generating their own solar power. Electricity is generated in power generating plants, transmitted through the power transmission grid and finally reaches the end consumer, the home of city residents or businesses.
