#### Does Arizona have a solar tax credit?

Arizona's state tax credit equals 25% of solar power system costs, up to \$1,000. Most solar installations will earn the maximum \$1,000 incentive. The Arizona solar tax credit will lower your state income tax liability. Much like the federal tax credit, you won't get these savings until you file your return for the year. Quick Facts

#### Are there solar rebates in Arizona?

There are no statewide Arizona solar rebates, but it does have the AZ solar tax credit. Arizona's tax credit is equal to 25% of system costs up to \$1,000, and it reduces your state income tax liability. There may be local energy efficiency rebates and financial incentive programs available to you.

#### How do I get a solar energy credit in Arizona?

See Form 310 instructions for more qualifications and how to file properly to claim the credit. Sales tax exemption: Arizona offers a 100% state sales tax exemption on the purchase and installation of solar energy equipment, up to a limit of \$5,000 per device.

#### What solar tax incentives are available in Arizona?

The federal solar investment tax credit (ITC) is the most significant solar incentive in Arizona. You may also take advantage of tax breaks, rebate programs or incentives through Mohave Electric Cooperative or the City of Scottsdale.

Does Arizona offer solar power performance payments?

Arizona does not offer Solar Power Performance Payments, also known as production incentives. You can claim the credit for your primary residence, vacation home, and for either an existing structure or new construction. As a credit, you take the amount directly off your tax payment, rather than as a deduction from your taxable income.

#### Are solar batteries tax deductible in Arizona?

There is no statewide solar battery rebate or incentive Arizona. However, energy storage systems qualify for the 30% federal tax credit as long as the battery has a capacity rating of at least 3 kWh. A battery like the Tesla Powerwall 3 costs about \$16,000 when fully installed, earning it a tax credit of \$4,800!
