Arizonans consume more energy than most other states' residents, which means they require larger systems to offset their monthly use.

Are there solar rebates in Arizona?

There are no statewide Arizona solar rebates, but it does have the AZ solar tax credit. Arizona's tax credit is equal to 25% of system costs up to \$1,000, and it reduces your state income tax liability. There may be local energy efficiency rebates and financial incentive programs available to you.

How much can you save on solar panels in Arizona?

Solar panel systems in Arizona are expensive, but incentives from the state and federal governments can help you reduce the upfront cost. Between the federal tax credit and other state-specific incentives, you can save thousandson solar panels, making them well worth the investment.

What tax benefits does Arizona offer for solar panels?

Are solar batteries tax deductible in Arizona?

There is no statewide solar battery rebate or incentive Arizona. However, energy storage systems qualify for the 30% federal tax credit as long as the battery has a capacity rating of at least 3 kWh. A battery like the Tesla Powerwall 3 costs about \$16,000 when fully installed, earning it a tax credit of \$4,800!
