When did Australia start a solar rebate program?

Australia introduced its federal solar rebate program in 2001 with the Renewable Energy Target (RET). The RET later split into two parts: the Small-scale Renewable Energy Scheme (SRES) for residential and small business installations, and the Large-scale Renewable Energy Target (LRET) for larger commercial projects.

Technically, federal solar incentives under the Small-scale Renewable Energy Scheme (SRES) don't provide a direct cash rebate. Instead, solar systems generate Small-scale Technology Certificates (STCs), which have a market value and can be sold to offset installation costs.
