Where can I buy CATL (CATL) stock?

CATL stock trades on the Shenzhen Stock Exchange(SZSE). As a result, typically, the easiest and safest way to get exposure to CATL is to buy shares in battery-focused exchange-traded funds (ETF) that hold CATL. For example, CATL stock is included in VanEck ChiNext ETF (NYSE: CNXT) and KraneShares Bosera MSCI China A 50 Connect Index (NYSE: KBA).

What does CATL's new funds mean for China's battery industry?

With the new funds, CATL plans to strengthen its international operations, including battery production facilities in Hungary, Spain, and Indonesia. The move reflects a broader push by Chinese companies to secure overseas growth while reducing dependence on Western markets.

How to buy CATL stock in Shenzhen?

The easiest way to get exposure to CATL is to buy shares of ETFs that hold CATL in their portfolio, such as VanEck ChiNext ETF (NYSE: CNXT), where CATL makes up around 18%. Alternatively, since CATL is listed on the Shenzhen Stock Exchange (SZSE), you can buy CATL stock directly from brokersthat offer exposure to SZSE. Where to buy CATL stock?

Is it possible to buy CATL shares?

While many investors are interested in CATL due to its involvement in the EV market, CATL does not trade on a US exchange, making it challenging for US investors to purchase shares directly. However, this article provides information on how you can still buy CATL shares.

What is the stock code for CATL on the Shenzhen Stock Exchange?

CATL trades on the Shenzhen stock exchange (300750.SZ). This will be an issue for US investors who use brokers that don't handle overseas markets. While the Shenzhen listing is a deterrent for US investors, it also alleviates a key risk for Chinese stocks.

On which exchange are CATL shares traded?

CATL shares trade on the Shenzhen exchange, which makes a purchase complicated for many US investors. CATL are seen as the leaders of lithium iron phosphate technology (LFP battery) and are a publicly traded company.
