

Who makes EV batteries in China?

A few years after opening the plant,CATL became the battery supplier for nearly all EV manufacturers including nearly all Chinese EV companies,taking the lead in the movement from fossil fuels to renewables.

Where are CATL batteries made?

In 2019,the battery giant broke ground in central Germany to build a \$2 billion CATL battery gigafactory for BMW and Volkswagen. The factory covers 57 acres and has the capacity to build batteries for hundreds of thousands of cars annually. CATL began building this assembly facility when it was still a young,8-year-old company.

How many battery factories does CATL have?

As of last year,CATL operates 13 battery factories around the world,including in China and Germany,according to the filing. The firm has previously announced it was working on a joint venture in Spain with Stellantis,the owner of Fiat and Chrysler,to build a battery plant. It's separately planning battery-related projects in Indonesia.

Is CATL launching a new EV battery plant in Europe?

On Tuesday,CATL's Vice Chairman Pan Jian announced at the World Economic Forum in Davos that CATL will unveil a new EV battery plant joint venture in Europe with a local automaker. "We expect to announce new joint venture factory projects with other OEMs in Europe this year," Pan said,according to Interface News.

Does CATL manufacture lithium ion batteries?

CATL has more than half of the metal-refining capacity needed for battery manufacturing, including 93% of the manganese and 100% of graphite needed for lithium-ion batteries. CATL has invested in maintaining its position as a global leader in battery manufacturing.
