What is the Cumberland County Landfill?

The Cumberland County Landfill is a facility for burying trash and garbage below secured and stratified layers of dirt and isolating material. It is regulated by the U.S. Environmental Protection Agency and applicable state laws. The landfill accepts various types of waste, including tire, solid waste, hazardous waste, and inert material waste.

How many container sites does solid waste management have?

Solid Waste Management operates 17 container sites for Cumberland County homeowners only.

Will yard waste be picked up in Cumberland County?

Any yard waste mixed with regular refuse will not get picked up until refuse is removed. This is a Cumberland County Landfill rule and the town can get fined for not complying. Piles of limbs must be of a size 5' (feet) X 5' (feet) x 3' (feet) or less for weekly pickup at no additional charge.
