

Does SCE pay for solar?

Under the new NEM 3.0 rules, the price that SCE will pay you for solar you send to the grid is set to drop by about 75%. However, if you act now, you can still lock in net metering 2.0 (NEM 2.0) rates, which will save you about 60% more over 20 years compared to NEM 3.0.

How many solar customers does SCE support?

SCE supports over 250,000 solar customers (and more every day!) who are connected to the energy grid. Customers can also purchase clean electricity exclusively generated by solar when they enroll in the Green Rate plan.

Does SCE offer solar incentives?

SCE doesn't offer solar incentives for every homeowner. However, the California Solar Initiative has two rebate programs that low-income households in SCE's service territory can qualify for: the Single-Family Affordable Solar Housing (SASH) and Multi-Family Affordable Solar Housing (MASH) programs.

When can you use the credits from your solar panel system?

These credits can be used when your solar panel system isn't producing enough power to meet the electricity demands for your home or business. Southern California Edison's net metering program makes it possible for solar energy system owners who are connected to the grid to receive credit for their excess solar electricity.

How the SCE Solar Program Works. Solar energy generated from your own solar panel system can be used to power your home, store energy in a home battery, or sell the power back to the electricity grid. To power your home, you need a solar system and sunlight. To store energy for future use (like at night), you need a special home battery.

Under NEM 2.0, customers who generate solar energy and feed excess electricity back into the grid are credited at the retail rate for the energy they export. If you installed a solar energy system or got a design registered with your local utility ...
