

How many solar energy centers are there in Florida?

Does Florida Power & Light offer net metering?

Yes, Florida Power and Light offers a net metering program for customers who go solar. With full retail net metering, your home consumes the solar energy produced on your roof first. If you generate more solar energy than your home needs, the electricity gets sent to the grid, and FPL will put a credit on your bill to offset your future usage.

What is FPL SolarNow?

FPL SolarNow is a community solar program that brings solar power to Florida through hundreds of solar arrays across the state. With the support of dedicated participants, it enables customers to benefit from solar energy without installing panels on their own property.
