

What grants are available for solar energy projects?

The federal government offers several grant programs to support solar power farms and other solar energy projects. These include grants from the Department of Energy and the Department of Agriculture.

How much is a solar energy grant?

The maximum grant amounts for solar energy projects have ranged as high as \$3 million and are available to local governments, schools, nonprofit organizations and other eligible applicants. States and local governments offer a wide variety of assistance programs in support of solar energy projects.

Are solar power farms eligible for Grant funding?

Solar power farms are eligible for Grant funding, along with other solar projects and alternative energy sources. Maximum grant amounts have ranged as high as \$3 million and are available to local governments, schools, nonprofit organizations and other eligible applicants.

What is a 'Solar for All' grant?

A 'Solar for All' grant is funding provided to enable low-income and disadvantaged communities to deploy and benefit from residential distributed solar.

What is the \$7 billion Solar for All program?

The \$7 billion Solar for All program aims to create and expand low-income solar programs. Under this program, 60 grant recipients will enable over 900,000 households in low-income and disadvantaged communities to benefit from distributed solar energy.

Who will receive a \$7 billion solar grant?

The U.S. Environmental Protection Agency announced 60 selectees that will receive \$7 billion in grant awards through the Solar for All grant competition.
