

Who invested in Solid Power?

Solid Power was initially funded by prominent investors including Hyundai, Volta Energy Technologies, Umicore, Sanoh, A123 Systems and Solvay. From the outside, Solid Power is an industry-leading developer of all-solid-state battery cells.

Why did BMW invest in solid power?

The investment positions Solid Power to produce full-scale automotive batteries, increase associated material output and expand in-house production capabilities for future vehicle integration. The BMW Group and Ford aim to utilize Solid Power's low-cost, high-energy all solid-state battery technology in forthcoming electric vehicles.

What is solid power's development strategy?

Solid Power's development strategy hinges on strategic collaborations with industry giants. The company has secured multi-year joint development agreements (JDAs) with BMW and Ford Motor Company (F), allowing these automakers to integrate its solid-state battery technology into their future EV platforms.

Are solid-state batteries a good investment?

If solid-state batteries are able to extinguish range anxiety, there will be plenty of upside for shares of both Solid Power and QuantumScape. That's a big "if" though, so any investment should be considered completely speculative, even after today's positive gains.
