Is it legal to have solar panels in Florida?

According to Florida statute, it is not unlawful for any entity to block residents from having solar panels. Furthermore, Florida Power & Light (FPL) does not mandate that solar panels be powered down when the grid goes offline during a crisis.

Are solar panels free in Florida?

In Florida, you are legally mandated to connect any solar panels you have installed to the local grid, which means you are never truly free. To make matters worse, during a power outage, even if your system can sustain your entire home and family, you cannot rely on it. You must power down your system and generators.

Are solar panels exempt from property taxes in Florida?

Who can buy solar panels in Florida?

While anyonecan acquire solar panels, building management must usually approve them if you're in a multiunit property. If you own a home, Florida's Homeowners Association (HOA) would perform an inspection before and after your installation. HOAs can't legally prohibit anyone from acquiring solar panels (or any other renewable energy system).

What if Florida refuses to install solar panels?

If the state refuses your request to install panels, you have the right to ask why. They can't say no without a valid, documented reason.
