# Karnataka solar power development corporation limited

#### Who owns KSPDCL?

Under this scheme for the development of Solar parks in Karnataka, a JV company "M/s. Karnataka Solar Power Development Corporation Ltd (KSPDCL)" has been formed by KREDL and SECI. 11,000 acres of Land has been identied at PavagadaTaluk in Tumkur District, Karnataka for this purpose. KREDL and SECI own equal equity (50:50) of KSPDCL.

#### How big is Karnataka solar power Park?

The park is spread over approximately 12,937 acresof land. The balance of system for the solar power park was developed by Karnataka Solar Power Development Corporation Ltd (KSPDCL) so as to ensure plug and play mode of development in the solar park.

#### How much solar power does Karnataka have?

This financial year alone, the state added nearly 730 MWof solar-based electricity generation, compared with 572.82 MW in 2023-24,460.45 MW in 2022-23,228 MW in 2021-22, and 139 MW in 2020-21. Despite these numbers, experts say Karnataka is still lagging behind both its own targets and the progress made by other states.

### How many solar-powered agricultural pumps are there in Karnataka?

Karnataka currently has nearly 26 lakhagricultural pump sets that receive free power. Though KREDL and Bescom have completed the tender process, the actual installation of solar-powered pumps has been sluggish, at snail's pace, added Shivanna. As of now, the state is generating just 36.87 MW under the KUSUM-C scheme.

#### Which state is implementing multi MW capacity projects in Karnataka?
