What are marking on Liferaft container as per SOLAS ? maximum permitted height of stowage above waterline (depending on drop-test height and length of painter); launching instructions.

What markings are required on a liferaft container under IMO LSA Code?

(b) The markings required on the liferaft container under IMO LSA Code,as amended by Resolution MSC.293 (87),Chapter IV/4.2.6.3 (incorporated by reference,see § 160.151-5 of this subpart) must be on a plate or label sufficiently durable to withstand continuous exposure to environmental conditions at sea for the life of the liferaft.

What is the marking required on a liferaft?

The marking required on liferafts equipped in accordance with LSA code regulation 4.1.5.1 shall be " SOLAS A PACK" in block capitals of the Roman alphabet.

What markings are required on an inflatable liferaft?

(c) In addition to the markings required on the inflatable liferaft under IMO LSA Code,as amended by Resolution MSC.293 (87),Chapter IV/4.2.7.1, the liferaft must be marked with the-- (1) Manufacturer's model identification; (2) Lot number; and (3) U.S. Coast Guard approval number.

What is Alas a liferaft?

SOLAS A Liferaft means a liferaft that meets the requirements of this subpart for an inflatable liferaft complying with SOLAS and equipped with a SOLAS A equipment pack. SOLAS B Liferaft means a liferaft that meets the requirements of this subpart for an inflatable liferaft complying with SOLAS and equipped with a SOLAS B equipment pack.

What is a life raft?

Life raft is a survival craft used for sustaining the lives of persons in distress from the time of abandoning the ship. There are mainly two type of Life raft: General requirements for Liferafts Every liferaft shall be so constructed as to be capable of withstanding exposure for 30 days afloat in all sea conditions.
