Through the MA SMART solar program, the state's three investor-owned utilities compensate solar owners for the electricity their systems produce. The program is one of several solar incentives available in Massachusetts that reduces the cost -- and increases the savings -- of installing a home solar system.

What is the Massachusetts solar loan program?

The Massachusetts Solar Loan Program includes an interest rate buy-down, income-based loan support, and a loan loss reserve for qualified programs to help you get started. Lease your panels or sign a power purchase agreement (PPA) through a Third-Party Owner (TPO).

Are solar panels tax deductible in Massachusetts?

Federal and state tax incentives lower your costs. A federal tax credit allows you to deduct up to 26% of the cost of a solar panel system from your taxes, although this percentage will decrease in 2023. ² In Massachusetts, you can also receive 15% of the system cost as a credit against your state income tax, up to \$1,000.
