

Is solar energy a good option for your Mississippi home?

During the past decade, deployment of solar energy systems in the United States (U.S.) has grown rapidly. Cost reductions as well as new home-ownership and financing options have made solar energy a possibility for many Mississippi residents. Adding a solar power system to your property is a big decision.

Does Mississippi have a solar system?

According to the U.S. Department of Energy, Mississippi's residential electricity rates increased, on average, by 1.47 percent annually between 2006 and 2016. Some installers will include a guarantee of savings or the amount of energy expected to be produced by a solar system.

Who is a qualified solar installer in Mississippi?

According to Mississippi Power, a qualified solar installer in Mississippi should be certified by the North American Board of Certified Energy Practitioners (NABCEP). NABCEP is an organization that trains and certifies renewable energy professionals. The Mississippi Distributed Generation Rule also provides guidance on finding qualified installers.

What renewable resources does Mississippi Power use?

Mississippi Power uses biomass as a renewable resource. We receive the solar energy and renewable energy credits generated by these facilities, which we can use to serve our customers or sell to third parties for the benefit of our customers.
