The state of Nevada has laws that guarantee access to solar energy. This means nobody can restrict a person's usageof photovoltaic (PV) panels, including homeowner associations. Local laws override any contract, ordinance or legal document with unreasonable restrictions for renewable energy sources.

Does NV Energy have a net metering program?

NV Energy has the largest net metering program in Nevada. To participate in the NV Energy program, your solar energy system must pass an inspection from city or county building authorities. You can submit your solar project documents and application through the PowerClerk platform.

Can you get a solar tax credit in Nevada?

Leasing or entering a power purchase agreement (PPA) is often cheaper upfront, but you won't be eligible for the federal solar tax credit and other financial incentives. Nevada homeowners may also get paid to register a renewable energy system to generate and sell portfolio energy credits.
