The federal solar creditis one of the most appealing financial incentives for solar conversion available in Ohio. Do you qualify for solar incentives?

Although Ohio does not offer a specific solar tax incentive, they do have an SREC market. In this market, you can produce energy and then earn and sell Solar Renewable Energy Certificates (SRECs). These certificates are similar to stocks and can help you save money each year.

Ohio has a couple of excellent incentives for homeowners that want to go solar. The federal tax credit, plus an excellent solar buyback program (called net metering) can save you thousands on the upfront cost of solar panels and your future energy costs--making solar an excellent investment. What incentives are available for solar panels?

Available in five or seven year terms. The Residential Clean Energy Credit, formerly known as the federal investment tax credit (ITC), can reduce your solar panel system's cost by 30%. Your entire system qualifies for this incentive, including equipment, labor, permitting, and sales tax.

Does Ohio offer a solar battery tax credit?

Ohio doesn't offer any state-specific battery incentives. However, all batteries above 3 kWh in size are eligible for the 30% federal tax credit. Since Ohio offers an excellent net metering program, there's not a great financial incentive to get a solar battery.
