Did powerhome solar/pink energy abruptly terminate its employees?

Local news is reporting that Powerhome Solar/Pink Energy terminated all of its employees nationwide abruptlyand has closed. North Carolina-based Powerhome Solar officially changes its name to Pink Energy today, April 22.
