Remind prospective customers that while tax credits,rebates,and incentives might be available for solar purchasers who qualify,offers for "free" or "no cost" solar panels are scams. Comply with the law: old and new. Reputable companies know the importance of being honest about what they're offering - and how much it costs.

Is there hope for homeowners involved with a now-defunct solar panel company?

HAMPTON ROADS,Va. (WAVY) - There might be some hopefor homeowners involved with the now-defunct solar panel company Pink Energy,formerly known as Power Home Solar. 10 On Your Side has been investigating the company for more than a year.

#### Do you owe a loan for a solar system that doesn't work?

Consumers owe millions of dollars in loan payments for solar power systems they say don't work. WBTV filed a records request and found more than 80 complaints filed in North Carolina against Pink Energy, formerly known as Power Home Solar. Alexander Peets is one of Pink's customers who filed a complaint with NCDOJ.

#### Is powerhome solar a nightmare?

So,News 5 Investigators dug deep into a company called PowerHome Solar that's seen hundreds of complaints from irate customers across the country. "So,this is what we paid nearly \$30,000 for," said Mark Mondello from Suffield,who stood in his driveway staring up at his roof. He told us his solar project has been a nightmarewith PowerHome Solar.

#### Did power home solar deliver on sales pitches?

Numerous customers from around Ohio and the country filed complaints and lawsuits claiming Power Home Solar never delivered on its sales pitches. Now, the Ohio Attorney General's Office has made a move against the company. "The whole process was just really misleading," said Phil Luketic.
