Is it acceptable to use a sole proprietorship name in a PoA?

If an individual operates a sole proprietorship and the POA's language encompasses the operation of the business, yes, it would be acceptable for that purpose. That would be true regardless of whether the individual operated the sole proprietorship under an assumed name or his real name.

Is a DBA a sole proprietorship?

"DBA" is not a synonym for a sole proprietorship. A power of attorney gives an individual or trust department power over the affairs of an individual. What is a power of attorney?

A power of attorney (POA) or letter of attorney is a written authorisation to represent or act on another's behalf in private affairs, business, or some other legal matter, sometimes against the wishes of the other.

Who must execute a power of attorney in a partnership?

In the case of a partnership, a power of attorney must be executed by all partners, or if executed in the name of the partnership, by the partner or partners duly authorized to act for the partnership, who must certify that he/she has such authority. (6) Dissolved partnership.

Can a company be a power of attorney?

Dear Mr. Vinod, As rightly pointed out by you, Section 1A of the Power of Attorny Act clearly stipulates that POA can be given only to a specified person. Company, which is a body corporate (may be a legal person) but not a specified person, cannot be made the Power of Attorney.

What is the difference between DBA and power of attorney?

DBA means "doing business as" or operating under an assumed name. Corporations,partnerships,LLC's; i.e. virtually any entity,can operate under an assumed name. "DBA" is not a synonym for a sole proprietorship. A power of attorney gives an individual or trust department power over the affairs of an individual.
