# Rebates for electric car charging stations

How many EV charging stations can I get a rebate?

Rebates are limited to one one EV charging stationrebate per household. For more information, see the KUA website. Carroll EMC Members who lease or purchase a new BEV could qualify for a monthly credit of \$30 on their power bill to cover the cost of charging the EV for one year.

### What is the federal tax credit for EV charging stations?

Any business can apply for a tax credit for up to 30% of the cost of purchasing and installing EV chargers, up to \$30,000. If your business owns multiple locations, you can apply for the credit at each site. Starting January 1,2023, new qualifications will go into effect that change how the Federal tax credit for EV charging stations works.

### Does bed offer a rebate on EV charging stations?

BED also offers a rebate of up to \$900for the purchase and installation of a qualifying Wifi enabled EV charging stations for customers that have enrolled in BED's Residential EV Rate. Eligible applicants must have purchased an EV charging station within 60 days of the acquisition of the EV.

### How do EV charging stations make money?

You'll make money from the EV chargers themselves, plus anyone who wanders into your business while waiting for their car to charge. There are three main types of EV charging station incentives: tax credits, grants, and rebates. While new incentive programs pop up every few months, here are three of the most important ones to know about.

#### Are EV chargers eligible for a rebate?

Residential electric customers are eligible for a \$600rebate when they install a qualifying "Wi-Fi enabled" or "Internet Connected" EV charger at their home. Residential customers are eligible for a \$200 rebate when they install a standard (Non Wi-Fi/Non Internet Connected) EV charger.

## Do EV chargers get tax credits?

Many utility companies and some state governments also offer tax credits, rebates, and other incentives for installing EV chargers. The DSIRE database is a great place to check for incentive programs in your zip code. What is the federal EV charger tax credit?
