

Will Reliance Power build India's largest solar power plant?

The company plans to build Asia's largest solar power and energy storage facility, along with an integrated solar manufacturing plant, aiming to boost India's renewable energy capacity and create thousands of jobs. Reliance Power's renewable energy arm, Reliance NU Suntech, will develop a 930 MW solar power plant in Kurnool.

Will Reliance Power Invest in Andhra Pradesh?

Reliance Power which is under the leadership of Anil Ambani, is set to invest over Rs 10,000 crore in Andhra Pradesh. The company plans to build Asia's largest solar power and energy storage facility, along with an integrated solar manufacturing plant, aiming to boost India's renewable energy capacity and create thousands of jobs.

Who is Reliance Solar?

Solar manufacturing In October 2021, Reliance acquired REC Solar Holdings, a Norway-headquartered solar cell, modules, and polysilicon manufacturing company known for its high-efficiency solar panels of Heterojunction Technology (HJT).

When will Reliance Power's Solar power plant be operational?

The facility aims to be operational within 24 months of finalising a power purchase agreement with the Solar Energy Corporation of India (SECI). Alongside the solar power plant, Reliance Power plans to invest Rs 6,500 crore in an integrated solar manufacturing facility.

Will Reliance Power buy solar power in India?

Under this order, the Reliance Power subsidiary will guarantee a peak power supply of four hours daily (or a 4-hour discharge duration). SECI will enter into a power purchase agreement (PPA) with Reliance NU Suntech for a period of 25 years and the solar power procured will be sold to multiple discoms in India.

Will Reliance Power invest Rs 6500 crore in solar power plant?

Alongside the solar power plant, Reliance Power plans to invest Rs 6,500 crore in an integrated solar manufacturing facility. The company is scouting 1,500 acres of land near Visakhapatnam for this purpose, with plans moving towards finalising a site near the Rambili industrial area.
