Is Rocky Mountain Power a residential or non-resident program?

Yes, residential and non-residential Rocky Mountain Power customers with electrical service in Utah, Idaho and Wyoming are eligible to participate in the program. Can I request to be removed from the program? Yes, customers can be removed from the program after providing 30-day advance notification to Rocky Mountain Power.

Does Rocky Mountain Power offer net metering?

Rocky Mountain Power offers net metering or net billing compensation to customers in Idaho, Utah, and Wyoming. In Idaho, there is no overlap between service areas for Rocky Mountain Power and the state's other large energy suppliers, Avista Utilities and Idaho Power.

Does Rocky Mountain Power offer metering credits in Utah?

Importantly,Rocky Mountain Power doesn't offer full retail ratefor their net metering credits in Utah: as of 2021,customers receive a credit rate of about 6 cents per kilowatt-hour (kWh),or roughly half of the retail rate. UAMPS is still in the process of creating a rate structure for its customers.

Can customers be removed from the Rocky Mountain Power Program?

Yes, customers can be removed from the program after providing 30-day advance notification to Rocky Mountain Power. If you decide to withdraw from the program during your commitment period, you will be required to payback a prorated portion of the incentive to Rocky Mountain Power based on the length of time you participated in the program.

How does Rocky Mountain Power verify a battery?

Rocky Mountain Power verifies ability to communicate and dispatch the battery. Will participating in the program negatively impact my battery? Rocky Mountain Power will have the ability to turn the battery on and off, as such participation in the program should not negatively impact your battery beyond what it is designed to do.

How can I get solar power in Utah?

You can get solar power in Utah by subscribing to a 20-megawatt solar plant in Millard County. Choose between offsetting your usage on your bill with blocks of 200-kilowatt-hours (kWh),or opt for full coverage where all of your kWh is billed on the Subscriber Solar rate. Keep your subscription for up to 20 years.
