

What is SK Innovation's Partnership with solid power?

SK Innovation today announced a partnership with Solid Power, an industry-leading developer of all-solid-state battery cells, to develop all-solid-state batteries under a memorandum of understanding ("MoU") and joint development agreement ("JDA") on Oct. 28, 2021.

Will SK Innovation buy solid power?

SK Innovation also commits to make a USD 30 million (approximately, KRW 35.325 billion) investment to acquire a stake in Solid Power. Solid Power is known as a leading developer of all-solid-state batteries.

What does SK Innovation see potential in?

Now, SK Innovation sees potential in Solid Power's proprietary solid electrolyte, as the company looks to partner up to see the development of these EV solid-state batteries across the finish line to implement them into its own production processes.

Will solid power and SK Innovation develop solid-state batteries?

Solid Power has announced a memorandum of understanding with SK Innovation to jointly develop solid-state batteries using the former's proprietary sulfide-based solid electrolyte.

Will solid power supply SK Innovation electrolyte?

Solid Power plans to supply SK Innovation with its proprietary electrolyte for use in the manufacturing of all-solid-state cells. Under terms of the JDA, Solid Power expects to generate a small amount of revenue from both research and development and from the sale of electrolyte samples beginning in 2022.

What is SK On doing with solid power?

Research and Development. Under the research and development license, SK On will license Solid Power's solid-state cell designs and manufacturing processes in exchange for payments totaling \$20 million from 2024 to 2027, upon achievement of milestones.

SK Innovation says that the investment in Solid Power will be a strong foothold in the all-solid-state battery market as Solid Power "has the world's best all-solid-state batteries technology."
