What is the California Solar mandate?

What is California's 2020 solar mandate?

California's 2020 Solar Mandate requires all newly built homes to install solar photovoltaic systems. These requirements are based on the floor area of the home and the climate zone. The solar panel systems must be sized to provide for the full annual energy usage of the home.

Are solar panels mandatory in California?

Starting January 1,2020, if you're building a single-family home, a townhouse, or a low-rise multifamily building (three stories or less), solar panels are mandatory. No exceptions, no wiggle room. The idea here is straightforward: every new home in California should generate enough solar energy to cover its annual electricity needs.

Does California require solar for new homes?

The updated California solar mandates of 2020 required that all newly built residential homes meet Title 24 requirements. This update made California's code the first in the nation to require solar for newly built homes!

Does California have a solar PV system?

Title 24 of the California Energy Code locked this in back on January 1, 2020. Think about it: every new home, every low-rise multi-family unit (up to three stories) has to come with a solar photovoltaic (PV) system. California's not messing around when it comes to clean energy goals. This isn't some pie-in-the-sky initiative, either.

Are you exempt from California's Solar mandate?

Yes, there are situations in which you may be exempt from California's solar mandate and do not have to include solar power in your new build. Here are three of the most common exemptions. If your home is destroyed in a natural disaster like a fire or earthquake and you have to rebuild, there is a chance for an exemption to the mandate.
