In Colorado, a typical residential solar panel system costs \$10,605 to \$30,300, depending on the size of your system and what financial incentives you qualify for. The 30% federal solar investment tax credit (ITC) is the most significant financial incentive for most homeowners buying solar panels in Colorado.
