Solar power incentives in South Carolina help make renewable energy resources more accessible for all. There is no denying that solar panels are expensive, and avg costs of panels in South Carolina can lead residents to pay anywhere from \$26,160 to \$45,780, with an average of \$35,970, for their solar systems.

Does South Carolina have a solar tax credit?

South Carolina's state tax credit for solar energy allows residents to claim 25% of their solar installation costs as a tax credit, up to \$3,500. Net metering allows South Carolinians to receive credits from their utility company for excess power their panels produce. Are solar panels tax deductible in South Carolina?

South Carolina offers its residents many money-saving incentives for solar. You can get tax credits, property tax exemptions, rebates and loans. There are two money-saving tax breaks available statewide in South Carolina: Personal tax credit: You can receive a state income tax credit equal to 25% of the costs of a new solar system.

Are solar panels a good investment in South Carolina?

Installing solar panels in South Carolina can be a good investment due to the availability of significant tax credits. The combined federal and state tax credits offer a discount of 55% on the cost of installation. Customers of Santee Cooper will also receive further rebates of several thousand dollars.

Does South Carolina offer solar rebates?

As of early 2024, South Carolina's major utilities, Dominion and Duke, do not offer solar rebates. However, South Carolina does offer a solar property tax exemption in addition to other rebates and tax credits.

How much does solar cost in South Carolina?

After the full federal solar investment tax credit, the average system is \$20,944 in South Carolina, which is more expensive than in many other states. The national average is \$16,715. The overall cost may be high, but there are some local incentives to help you go solar for less. The average federal tax credit value is \$8,976 in South Carolina.
