How to register on upneda solar energy portal as an investor?

To Register on UPNEDA Solar Energy Portal as an Investor, fill User Type (Organization/Individual), Organization/Company/Firm Name, Authorized Person's Name, Legal Status (in case of Organization), Mobile Number, Email ID, Have you signed MoU through Nivesh Sarathi Portal?

Do I need to register a solar PV system?

Additional restrictions may apply if you live in a listed building, conservation area, or national park. You must register your solar PV system with your Distribution Network Operatorif you plan to install one in your house (DNO). The DNO is the business in charge of supplying electricity to your residence.

How to register a generating company in CEA E-registration portal?

The registration number would be generated online by the generating companies/project developers, after filling in certain details. The Generating Companies would have to register themselves in e-Registration portal of CEA after filling in necessary details viz. name of the generating company, sector etc. in a format designed for the purpose.

Who is eligible for establishing rooftop solar power project under MNRE?

Any individual, including from Scheduled Castes and Scheduled Tribes, is eligible for financial support for establishing rooftop solar (RTS) power project under PM Surya Ghar Muft Bijli Yojna of Ministry of New and Renewable Energy (MNRE).

How do generating companies register their generating units?

They can choose any user id and passwordwhile registering their generating units. Using the user id and password generated, generating companies can enter the details of their generating units one by one for obtaining the unique Registration Number for each generating unit.
