Is SunPower Solar going out of business?

SunPower Solar, one of CNET's picks for best national solar companies, has filed for Chapter 11 bankruptcy and is selling most of its assets in an organization-wide wind down. The company is going out of business.

Will SunPower shut down if it can't sell?

The news was expected -- on Thursday,SFGATE reported on SunPower's dwindling fortunes and plans to lay off 290 California workers -- but it still represents a brutal fall for the company. SunPower was valued at \$10 billion as recently as 2021. Now, it will have to shut down the lines of business if it can't sell.

Why did SunPower's stock collapse?

SunPower's stock collapsed below \$1 this weekafter the company announced it was halting new leases, installations, and shipments. Guggenheim analysts suggested that this move likely signals the end of SunPower as an operating business.

Will SunPower go out of business if creditors demand payment?

SunPower Corp. shares plummeted more than 30% after the solar company warned that it could go out of business if creditors decide to demand immediate payment of its debt. The solar power equipment and services provider said that it wouldn't have enough liquidity to cover normal business operations if it had to pay its obligations.

What happens if SunPower goes bankrupt?

If SunPower goes bankrupt, customers may lose some initial warranty coverage, but they should still be covered by manufacturing warranties. Additionally, SunPower may sell its leases and PPAs as assets to another company, which would then assume the role of maintaining current customers' systems.

Why did SunPower's CEO resign?

In February,SunPower's CEO resigned after the company was subpoenaed by the US Securities and Exchange Commissionfor more information regarding allegations of financial misconduct by senior executives. This came after the end of solar leasing and power purchase agreements removed cheaper financing options for SunPower customers.
