Will EV tax credit beef up EV charging stations?

A Waymo autonomous self-driving Jaguar electric vehicle parked at an EVgo charging station in Los Angeles in May. New rules on a tax credit tied to electric vehicles could beef up investments in charging stations, a much-needed component for widespread adoption of EVs.

What is the electric vehicle charging tax credit?

For consumers who purchase and install an electric vehicle charger for their principal residence, the tax credit equals 30% of the cost, up to a maximum credit of \$1,000 per charging port.

Are EV charging stations eligible for alternative fuel refueling property tax credit?

The IRS and Treasury Department proposed rules Wednesday for the alternative fuel vehicle refueling property tax credit, detailing eligibility requirements for EV charging stations and other clean fuel infrastructure.

How much EV charger tax credit can a business get?

Before the IRA, the limit on the amount of the EV charger tax credit for businesses was \$30,000. That limit applies to projects that were completed before the end of last year. However, under the IRA, if you complete the business installation project after 2022, the tax credit per property item is up to \$100,000 per EV charger.

Are electric vehicle chargers tax deductible?

All of that means that while electric vehicle chargers are not entirely tax deductible, you might benefit, to some degree, from the tax incentives in the Inflation Reduction Act that apply for refueling property.

Do utility companies pay for EV charging stations?

Many utility companies throughout the U.S. offer rebate programs for commercial customers that install EV charging stations on their properties. Some of these programs, such as AEP Ohio's, offer to cover up to 100% of the costs. Your utility provider is the first place to check when you're weighing adding an EV charging station to your property.
