

How do solar incentives work in Texas?

Here's how solar incentives can help lower your system cost in Texas: You can claim the 30% solar federal tax credit -- worth \$4,410 in this case -- and your project cost decreases to \$13,290. Assuming you can claim additional incentives through one of the programs available in the state, your upfront cost will drop even more.

Does Texas have a solar tax credit?

Texas currently does not have a state solar tax credit, rebate program or net metering plan. Most incentives for solar energy in Texas come from local governments or specific energy companies. Texas does offer a statewide property tax exemption for solar panels.

Does Austin Energy offer solar rebates & incentives?

Austin Energy Solar Photovoltaic Rebates & Incentives: You can earn a rebate worth \$2,500 by installing a solar panel system at least 3 kW in size if you complete Austin Energy's solar education course.

The Residential Clean Energy Credit, formerly known as the federal investment tax credit (ITC), can reduce your solar panel system's cost by 30%. Your entire system qualifies for this incentive, including equipment, labor, permitting, and sales tax. The average cost for a 5 kW solar panel system is around \$10,823 in Texas.
