#### How much tax credit is available for solar PV installations?

For installations completed in 2018-2020 the maximum credit amount is \$1,600. For installations completed in 2021, the maximum tax credit will be \$1,200. In 2022, the maximum tax credit will be \$800. For installations after December 31,2023, there will not be a tax credit available for solar PV.

#### Can you get a tax credit if you install a solar system?

You can get a tax credit if you install a solar panel system in Utah. The state government will give you a credit towards next year's income taxes, reducing your solar costs by 25 percent of your total equipment and installation costs, up to \$800.
