Is solar supported in Virginia?

Yes, Virginia supports solar and renewable energy. The community of solar supporters in Virginia has worked for years to achieve legislation for it. They built support for solar house by house and community by community. A broad coalition came together to support solar and renewable energy.

Is it legal to build a solar system in Virginia?

It is now legal to build a system of this size for residential use. Permits larger solar systems. The bill increases the total size of solar systems built that can be built in Virginia. It raises the limit for residential systems from 20 kW to 25 kW. It raises size limits on commercial properties from 1 MW to 3 MW.

What is an "unreasonable restriction" on solar in Virginia?

The bill adds clarity to Virginia law. Current law prohibits HOAs from placing unreasonable restrictionson solar installations. The term 'unreasonable' is not defined in the law. 'I'm proud we were able to bring together homeowners and their associations to find a solution to grow solar in Virginia', Delegate Delaney said.

Do Virginians have to pay property taxes on solar?

Unfortunately,not all counties exempt renewable energy systems from property taxesin Virginia. However,as for grid-tied systems,a 2020 law improved net metering for Virginians and increased the size of residential solar systems eligible for net metering from 20kW to 25kW.

Can you go solar with a homeowners association in Virginia?

Virginia law protects your ability to go solar, even if your home is part of a homeowners association (HOA). HOAs can only stop you from installing solar if their recorded declaration explicitly prohibits solar installations. Many HOAs set appearance rules, but they cannot restrict your ability to go solar unless their rules explicitly state otherwise.

What document can stop you from installing solar in Virginia?

Homeowners associations can only stop you from installing solar if the HOA's recorded declaration explicitly prohibits solar installations. A recorded declaration is a legal document that lays out the rules of the HOA at its founding. Virginia law protects your ability to go solar.
