What power does the House of Representatives have?

The House has several powers assigned exclusively to it, including the power to initiate revenue bills, impeach federal officials, and elect the President in the case of an electoral college tie. The Senate is composed of 100 Senators, 2 for each state. What sole power is given to the House of Representatives?

What powers does the Senate have?

The Senate maintains several powers to itself: It ratifies treaties by a two-thirds supermajority vote and confirms the appointments of the President by a majority vote. The consent of the House of Representatives is also necessary for the ratification of trade agreements and the confirmation of the Vice President.

What powers does the Constitution give Congress?

The Constitution grants Congress the sole authority to enact legislation and declare war, the right to confirm or reject many Presidential appointments, and substantial investigative powers. The House of Representatives is made up of 435 elected members, divided among the 50 states in proportion to their total population.

Is the Senate more important than the House?

The Senate is often considered more important than the Housefor several reasons. While both chambers have exclusive and joint powers,the Senate's longer election cycle (six years compared to two for the House) contributes to its perceived importance.

What is the role of the Speaker of the House?

The Speaker of the House, effectively the nominee of the majority party, has a role that has evolved over time. As parties became more polarized from the 1980s onwards, the Speaker's role increasingly became to promote their party's agenda, particularly when the White House was controlled by the opposing party. Different Speakers have different styles.

What powers do both chambers of Congress have?

Both chambers of Congress have extensive investigative powers,and may compel the production of evidence or testimony toward whatever end they deem necessary. Members of Congress spend much of their time holding hearings and investigations in committee.
