The House has several powers assigned exclusively to it, including the power to initiate revenue bills, impeach federal officials, and elect the President in the case of an electoral college tie. The Senate is composed of 100 Senators, 2 for each state. What sole power is given to the House of Representatives?

What are two powers only granted to the House of Representatives?

Two powers specifically granted to the House of Representatives in the United States Congress are the power to initiate revenue bills (Article I, Section 7) and the power to impeach federal officials, including the President (Article I, Section 2).

What powers are reserved for the House of Representatives?

Several powers are reserved for the House of Representatives. These include: drafting appropriation bills, filing a case of impeachment against the President and electing a President if no candidate receives a majority of the electoral vote. Under Article 1 Section 2 of the US Constitution US Representatives reserve the powers:

What power does Congress have?

War Powers: Congress has the power to declare war and control military funding. Amendment Proposals: Both houses can propose amendments to the Constitution with a two-thirds vote. The House of Representatives holds the power to impeach federal officials, including the president, with a simple majority vote.

What responsibilities does the House of Representatives have?

This includes the House's exclusive power to initiate revenue bills and its role in impeaching federal officials, as well as the Senate's responsibilities in ratifying treaties, confirming presidential appointments, and conducting impeachment trials. 1.
