Impeachment relates to the removal of a Government official due to crimes committed while that individual was in office.

In the impeachment process, the House of Representatives brings articles (charges) of impeachment against an officialby a simple majority vote. If the House adopts the articles, the official has been impeached.

What are the grounds for impeaching a federal official?

An official can be impeached for treason, bribery, and "other high crimes and misdemeanors". The Constitution gives Congress the power to impeach federal officials. The House of Representatives brings articles (charges) of impeachment against an official.
