Are EV charging stations regulated in Florida?

Senate Bill 1084 amended Section 366.94 of the Florida Statutes, shifting the authority to regulate EV charging stations exclusively to the Florida Department of Agriculture and Consumer Services (FDACS). While the text of the new law is broad, the FDACS is considering a specific proposal at the upcoming hearing that would forbid local governments from requiring the installation of EV charging stations in any new or existing structures.

Can Florida build more electric vehicle charging stations?

Sen. Jeff Brandes (R-St. Petersburg) is sponsoring a proposal to encourage the construction of more electric vehicle charging stations in Florida. The proposal aims to use fees from license taxes to fund a new grant program for this purpose. A proposal meant to increase the number of electric vehicle charging stations in Florida passed its first committee stop today.

How many electric vehicle charging stations are there in Tampa?
